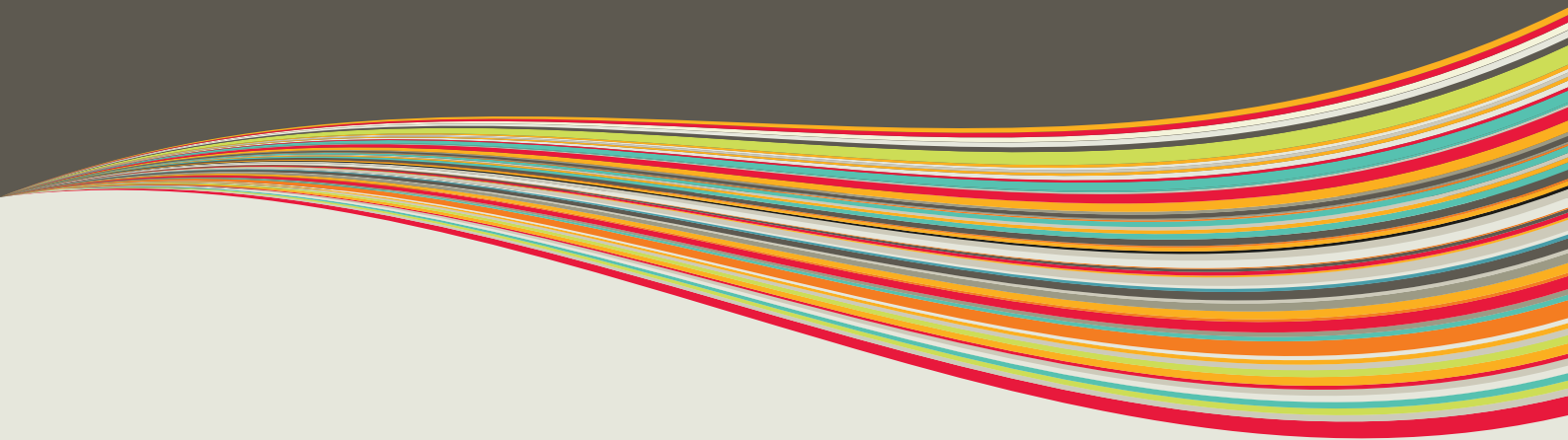

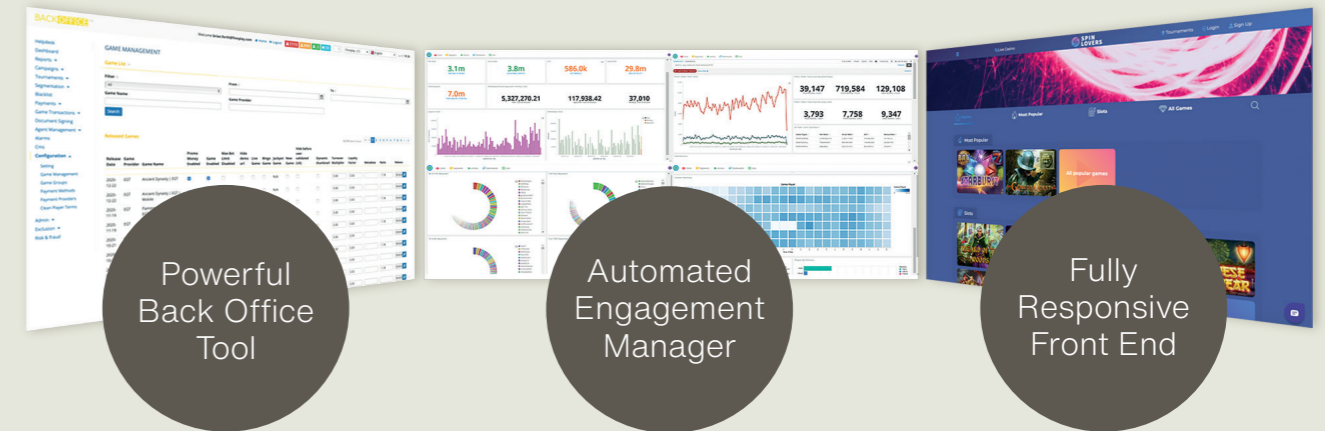

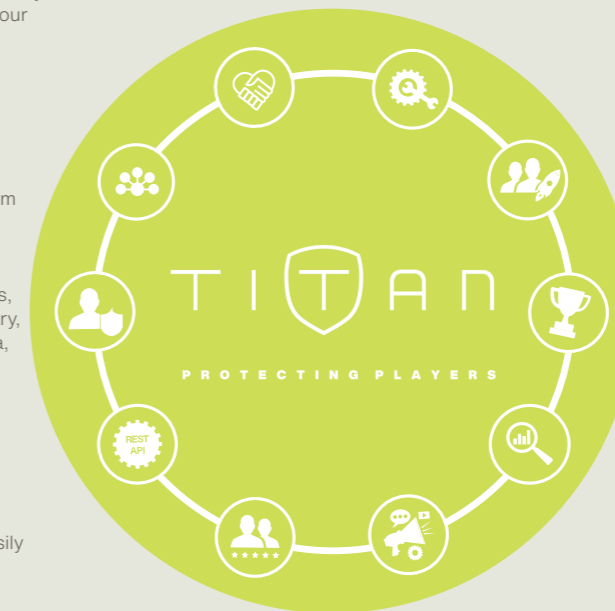

The application is highly customisable and integrates all the available games, payments and other third-party providers. Available for iOS and Android platforms.

Engagement Manager

The Engagement Manager is portal that integrates modern CRM tools to optimise return on investment by combining smart player segmentation with campaign automation and real-time analytics. 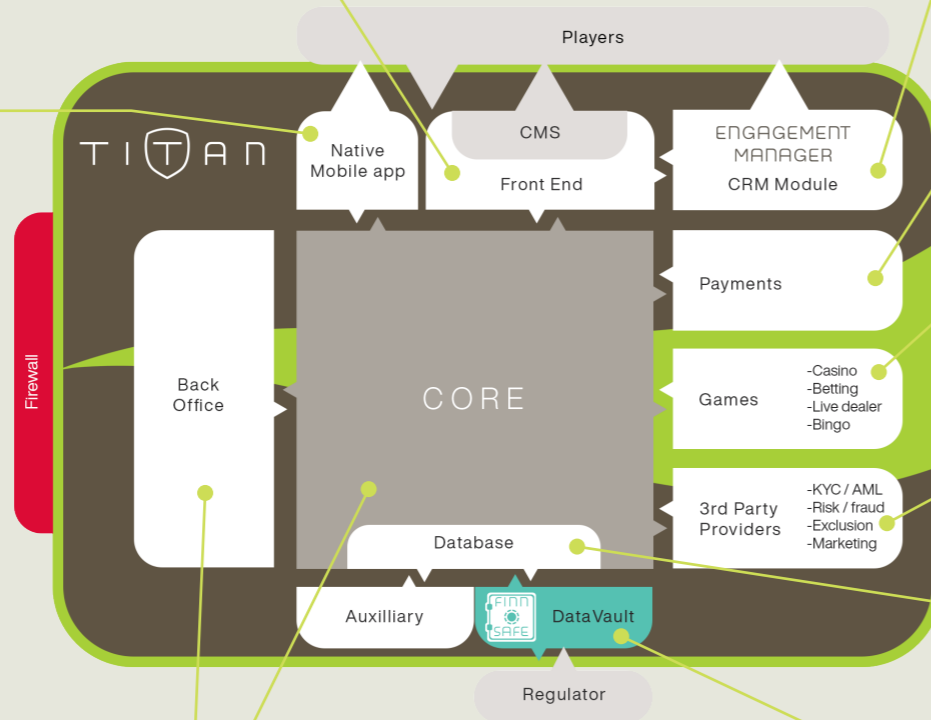

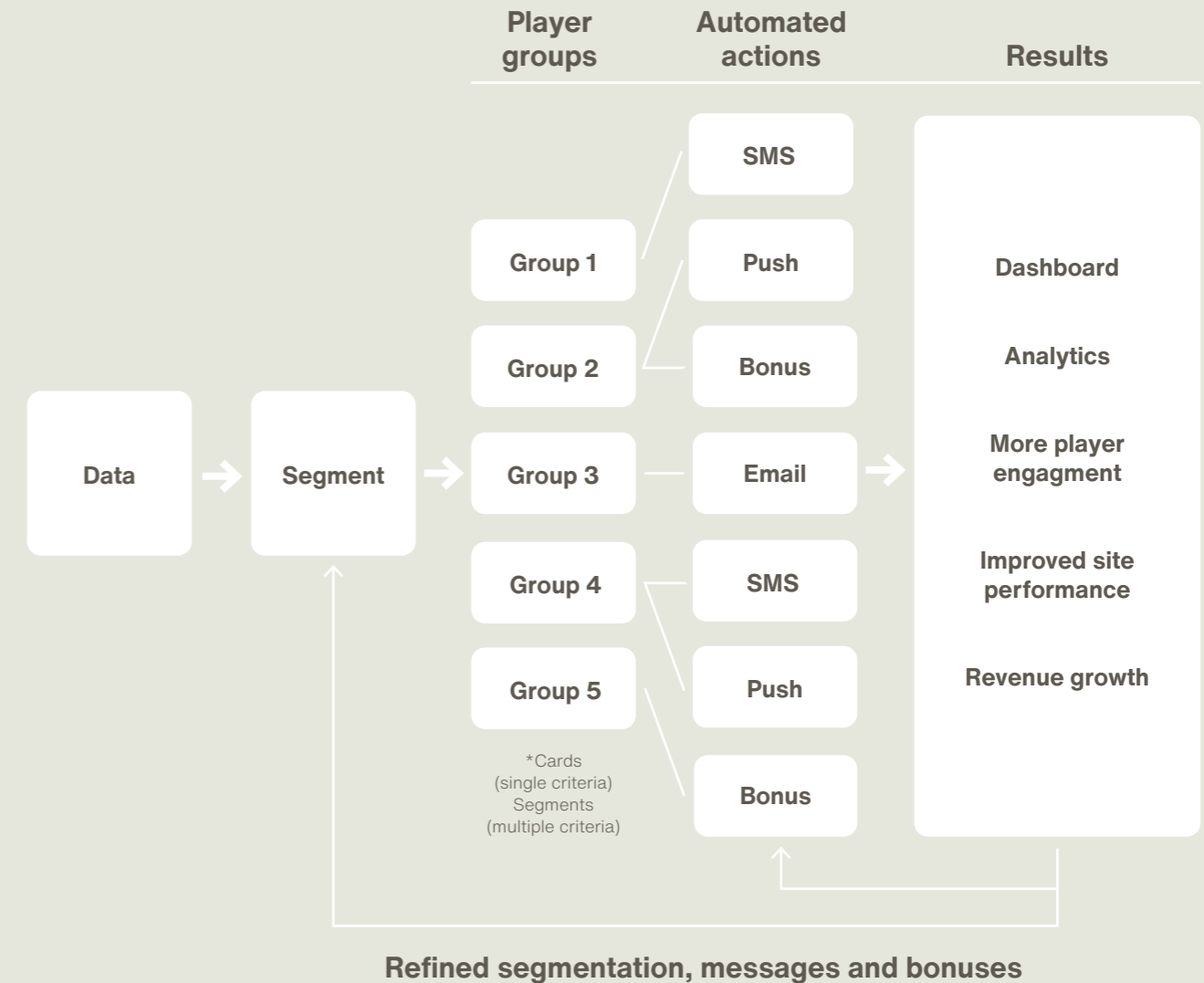


Engagement Manager

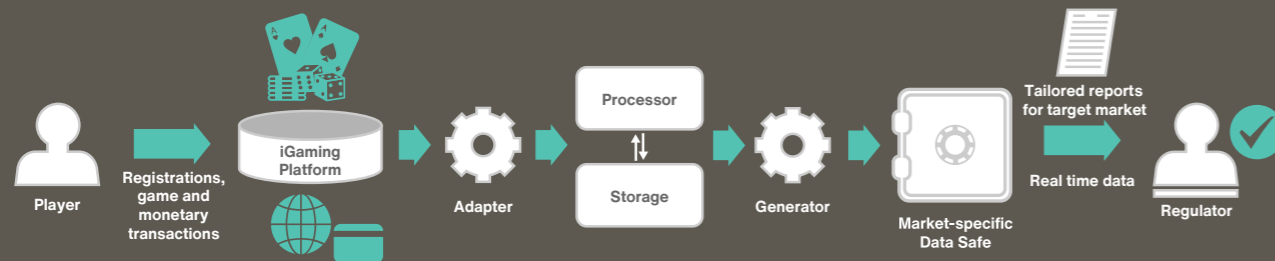
Finnsafe

- **Spain (Internal Control System ICS / Vault)**
- **Denmark (SAFE)**
- **The Netherlands (Control Database)**

FinnSafe is a versatile solution built to enable compliancy in markets like these by allowing regulators access to real-time data from a secure, dedicated server with a bespoke reporting tool. FinnSafe transmits all critical data such as registrations, game and payment transactions to a dedicated server running in parallel to the primary host server. The parameters for the data and reporting can be tailored to meet the requirements in each specific market.
